SCHOLARSHIP ELIGIBILITY & PROCEDURES

To be eligible, an applicant must:

- Be an employee, full or part time for at least 1 year, or a direct family member of an employee (child or spouse), of any New England Carwash Association member company.
- Have graduated high school or the equivalent.
- Be enrolled, or plan to enroll full or part time, in an accredited college or university, trade school, or certificate program.
- Not have won a scholarship from NECA in the past year.

Recipients will be evaluated and chosen based on their high school/academic standing, leadership capabilities, community involvement, strength of character, personal achievement, plan of study and future goals. Financial need also may be considered.

DEADLINE: May 3, 2024

Applicants must complete and submit the following:

- Scholarship Application Essay
- Two Letters of recommendation (*not from the parent or spouse of an applicant*)
 - One from a representative of the NECA member company
 - One from someone in the community
- Copy of acceptance letter or proof of enrollment from the post-secondary school or program the applicant plans to attend or is attending.
